Dear Président Emmanuel Macron,

We are now forced to write to you Président Emmanuel Macron through the FRENCH EMBASSY in Ottawa, Canada.

Président Emmanuel Macron, we have sent faxes to Ambassador Kareen Rispal from the French Embassy in Ottawa Canada since my wife Annette Martini was 4 months pregnant on Wednesday, July 12, 2017 and again on Tuesday, August 8, 2017 and

we have not received any assistance or any replies from the French Embassy in Ottawa Canada or from Ambassador Kareen Rispal with respect to EMERGENCY TRAVE DOCUMENTS. Nor did we receive any replies from the France Consulate in Toronto, Canada.

I Annette Martini am now 8 Months Pregnant, and I was hoping and praying by now that FRANCE would have respected International Laws and United Nations Laws and assisted myself and my husband to immediately leave Canada.

We were both hoping that the second we announced that we declared Emergency Refuge and Emergency Sanctuary and demanded Emergency Protection against Canada that the Country of FRANCE would have immediately assisted us with Travel Documents to immediately leave Canada but that never happened.

Président Emmanuel Macron, I did mention in my audio that I placed on my website at annettemartini.net addressed to you Président Emmanuel Macron, that the Province of Ontario and Canada will never allow me to enter the hospital to deliver our baby or our babies and Canada and the Province of Ontario would never give our baby or babies any Birth Certificate or any passports or any identifications.

577 Députés from the Assemblée nationale knew of our Emergency Situation and numerous Députés from the Assemblée nationale all went to my website of annettemartini.net and listened to my Emergency Plea addressed to you Président Emmanuel Macron.

We waited and waited for Emergency Help and unfortunately, we are still here stranded and STATELESS in Canada.

Canada has refused to issue my husband Anthony Martini and I any identifications from September 18, 2013 to the current date since we were forced back to Canada against our will.

Canada has refused to give us Passports or Emergency Travel Documents to leave Canada. This Persecution has been going on from Canada against my husband Anthony Martini since 1984 and since I met my husband in 1998 and shortly after I married my husband CANADA immediately started to Persecute me.

Canada illegally stripped my husband Anthony Martini from his Canadian Citizenship in 1984 and Canada illegally stripped me out of my Canadian Citizenship in 1998.

I Annette Martini have been STATELESS without a Country since 1998.

I Anthony Martini have been STATELESS without a Country since 1984.

While FRANCE believes that CANADA and the UNITED STATES are SAFE COUNTRIES under United Nations Laws we both can tell you that CANADA and the UNITED STATES OF AMERICA are NOT SAFE COUNTRIES.

Any person from any Country can be persecuted or tortured.

I Anthony Martini was physically tortured by the United States of America on orders of CANADA because Canada wanted me dead because I testified against Canada and the Canadian Federal Police Agency in Court in the United States of America.

Président Emmanuel Macron, I Anthony Martini am a Political Candidate for Prime Minister of Canada for 2019 and Canada will never give me any identifications to create a Political Party and Canada will never allow me to be run for Prime Minister of Canada or to ever be a Prime Minister of Canada.

I Annette Martini and I Anthony Martini are totally BLOCKED by Canada in leaving Canada, working in Canada, travelling in Canada, getting free medical in any province in Canada, getting any identifications or Travel Documents or Passports or paying Taxes or Collecting Taxes in Canada.

This new persecution from Canada has been going on for over 4 years since we both were forced back to Canada against our will.

Again, FRANCE believes that Canada is a SAFE COUNTRY under United Nations Laws which Canada is NOT a safe Country because Canada does order Political Assassinations and Canada does murder their Citizens and Canada does persecutes people in Canada and outside of Canada.

I Anthony Martini and I Annette Martini have not had any identifications since August 2010.

We both have been trying so hard to leave North America and we both have been communicating directly with the Country of FRANCE from 2009 to the Current Date.

The International Laws and the United Nations Laws demands that the Country of FRANCE immediately assist us and immediately Protect us and Immediately Assist us in leaving North America and permanently move to FRANCE.

The International Laws and the United Nations Laws are very clear that no Country can discriminate against a person or persons because of their Country of Origin.

France has assisted thousands of people from Africa and the Middle East and other war-torn countries but when it comes to myself Anthony Martini or myself Annette Martini coming from Canada then FRANCE just remains silent.

We were persecuted by Canada before the Iraq war, before the Afghanistan War, before the North Korea Threats and before the invasion of Europe by people from Africa and the Middle East.

We have waited and waited for FRANCE to assist us and all we received no actions. We received direct Communications from Ministre des Affaires étrangères in the past from Mme. Michèle Alliot-Marie and M. Laurent Fabius but again there were NO ACTIONS and NO PROTECTION and NO EMERGENCY HELP.

Président Emmanuel Macron, we are forced to place this letter on my Political Website of martiniforpm.com and my wife Annette Martini website of annettemartini.net because no one is respecting the fact that previous letters should have been given to you.

Again, I ANTHONY MARTINI and I ANNETTE MARTINI are declaring to you Président Emmanuel Macron and to the Country of France and to the French Embassy in Ottawa Canada and to Ambassador Kareen Rispal EMERGENCY SANCTUARY, EMERGENCY REFUGE and EMERGENCY PROTECTION,

Président Emmanuel Macron, again I must repeat myself and saying that CANADA and the Province of Ontario has refused for me Annette Martini to see a Doctor or Obstetrician-Gynecologist or to get treated at any hospital in the Province of Ontario or any hospital in Canada or to have my baby or babies delivered at any hospital in Canada and especially since I am pregnant.

Canada and the Province of Ontario has refused to give us free medical from September 18, 2013 to the current date.

If I Annette Martini am forced to remain in Canada then I will be immediately going to the FRANCE EMBASSY to deliver my baby or babies at the French Embassy because Canada will never ever give my baby or babies any citizenship, birth certificates or any identifications. At least our baby or babies will be born in FRANCE.

I am hoping and praying that FRANCE and you Président Emmanuel Macron will not force me into that situation but that will be our last resort and I will invite the world media.

Again, Président Emmanuel Macron I Anthony Martini and I Annette Martini are requesting your Immediate Assistance and the Immediate Assistance of the Country of France and the immediate Assistance from the FRENCH EMBASSY in Ottawa, Canada.

This letter is being sent by registered letter and this letter will be placed on our websites of martiniform.com and annettemartini.net in English and French within 72 hours after the French Embassy in Ottawa and Ambassador Kareen Rispal receives this Emergency Registered Letter.

Président Emmanuel Macron, please assist myself Anthony Martini and my wife Annette Martini and our unborn baby or babies in immediately leaving to France and with respect to Emergency Travel Documents and Emergency Sanctuary, Emergency Refuge and Emergency Protection.
