President Donald Trump, I, Anthony Martini and my wife Annette Martini supported you during the elections and I, Anthony Martini sent over 42 million emails to Americans to vote for you, Mr. President.

Mr. President, we need your immediate assistance with an urgent matter of you, Mr. President, giving myself, Anthony Martini and myself, Annette Martini, immediate American Citizenship.

Mr. President, we both are asking you, Mr. President, to conduct a criminal investigation into the illegal activities of the United States Government Employees from the U.S. D.O.J. (The U.S. Department of Justice, U.S. Homeland Security, ICE – (U.S. Immigration Customs and Enforcements) and D.H.S. – (U.S. Department of Homeland Security) for their direct involvement in Kidnapping myself, Anthony Martini and myself, Annette Martini and for the physical torture of myself, Anthony Martini.

Mr. President, we will make this letter as extremely short as possible.

I, Anthony Martini, was born in Italy.

I, Annette Martini, was born in Quebec, Canada.

I, Anthony Martini was persecuted by Canada for over 4 decades and Canada tried to murder me, Anthony Martini, for 3 decades because one of the reasons was because I used to be a Political Reporter and I exposed massive corruption of the Canadian Government. The other reason is because I, Anthony Martini was at the wrong place and wrong time as a reporter in Caracas, Venezuela and I witnessed three members of the RCMP – Royal Canadian Mounted Police from the Canadian Embassy in Caracas, Venezuela, executing an innocent man. The other reason was that as a Reporter, I discovered that the RCMP were using The Canadian Embassies and Canadian Consulates but mainly in the United States to ship massive Street Drugs like cocaine using Diplomatic Bags and Diplomatic Cargo. The RCMP to this date still distributes massive street drugs into the United States of America.

The RCMP stole my (Anthony Martini) Canadian Passport in 1985 and forced me to remain in Canada against my will and against all laws without ever going to Court because I witnessed the RCMP murdering an innocent man in Venezuela in 1984.

I had numerous attempted murders on my (Anthony Martini) life from the RCMP but in 1995 when I was a Political Candidate the RCMP tried to commit a Political Assassination on my life. I, Anthony Martini was made permanently disabled for the rest of my life and I again suffered severe head injury and suffered from long term and short term memory loss.

When I, Annette Martini married my husband Anthony Martini, the RCMP went after me and stole everything I ever had, including monies both business and personal and my two construction companies and no matter what business I, Annette Martini had, the RCMP illegally closed them down. Even when I was teaching Piano to students, the RCMP harassed and threatened my students' parents to prevent me from making any money of any kind.

The RCMP Illegally harassed and threatened our family doctors so our doctors would not give myself, Anthony Martini, heart pills or seizure medications so I, Anthony Martini can die.

In 2001, I, Anthony Martini and I, Annette Martini, after living underground in Canada for over 2 years were forced to surrender our Canadian Citizenship and all rights of being a Canadian.

However, recently I, Anthony Martini, discovered that Canada illegally stripped me out of my Canadian Citizenship in 1985 because I witnessed three members of the RCMP executing an innocent man in Cold Blood when I was a reporter in Venezuela.

Recently, I, Annette Martini, discovered that Canada illegally stripped me out of my Canadian Citizenship around 1998 without ever going to Court and without ever notifying me of their illegal actions.

In 2002, I, Anthony Martini and I, Annette Martini, wrote letters to former President George W. Bush, United States Attorney General John David Ashcroft, Former INS, United States Immigration and Naturalization Service and the U.S. State Department asking permission to legally enter the United States of America as Political Refugees from Canada.

I Anthony Martini, developed a 7 star Security System to protect the American People by LAND, SEA and AIR and I offered my system to Former President George W. Bush for FREE in exchange for my freedom, my wife's freedom and our

Immediate American Citizenship. This system is valued at 19 Billion dollars U.S. funds.

On July 24, 2002, I, Anthony Martini and I, Annette Martini, legally entered the United States of America with permission and I, Anthony Martini and I, Annette Martini were inspected twice at the U.S. Border Entry of Champlain, NY, Port Code: 0712, near Plattsburgh, NY and we were both admitted into the United States of America as LEGAL POLITICAL REFUGEES from CANADA.

I, Anthony Martini and I, Annette immediately sent a FAX to Former President George W. Bush at THE WHITE HOUSE and another FAX to Former U.S. Attorney General John D. Ashcroft at the DOJ – United States Department of Justice notifying the President of the United States of America and the U.S. Attorney General that we arrived safely in the United States of America and asked for emergency assistance.

The Emergency Assistance did not happen so we drove to Washington, D.C. and again we were forced to live in our car with no assistance of any kind and no emergency help. We lived in our Car three blocks from THE WHITE HOUSE and then we drove to the State of Florida.

We even went to the U.S. Department of Justice to speak with U.S. Attorney General John Ashcroft but no one was home.

At all times, Former President of United States of America George W. Bush and the U.S. Attorney General John Ashcroft knew all about our whereabouts and sufferings in the United States of America.

In September 2002, I, Anthony Martini hired an Attorney in Sarasota, Florida by the name of Victor Carl Krumm on Contingency Basis to file a lawsuit against VERSIGN for stealing nearly 4,000 Internet Domain Names from me and reselling those stolen Domains names and Verisign profiting over 9 Billion Dollars. Attorney Victor Krumm allowed myself, Anthony Martini and myself, Annette Martini to use his spare office to conduct investigations on each stolen domain name.

In April 2003, Attorney Victor Krumm tried to steal shares in our two American Corporations and I, Anthony Martini and I, Annette Martini made our 7th Police Report to the Sarasota County Sherriff Dept, in Sarasota, Florida. Of course, Attorney Victor Carl Krumm found out about myself, Anthony Martini and myself, Annette Martini making Police Reports against him from his friends at the Sarasota

Sheriff Department and KRUMM decided to file a False Police Report indicating that I, Anthony Martini stole his Computer and that I, Annette Martini was a co-defendant.

I, Anthony Martini and I, Annette Martini ended up being arrested at the Sarasota Sheriff Department while we were both trying to file our 7th Police Report against our Attorney Victor Carl Krumm.

I, Anthony Martini was arrested for 3rd degree theft and I, Annette Martini was arrested as a co-defendant. We were both NEVER Charged and we were being illegally held at the Sarasota County Jail for 30 days because we did not have any bail money to be released.

A few months later the case against myself, Anthony Martini and against myself, Annette Martini was dropped and abandoned by the State Prosecutor Earl Moreland.

I, Anthony Martini and I, Annette Martini filed a Lawsuit against the City of Sarasota, the Sarasota County Sheriff Department, our previous Attorney Victor Krumm, Attorney Ben Kay, the State of Florida, against a Police Deputy for Assault causing injury and others that were involved and of course that Lawsuit was illegally dismissed without ever going to Court.

The State of Florida refused to make an apology to us and refused to remove the illegal arrest against us in the files.

The U.S. Department of Justice had full knowledge that my (Anthony Martini) computer was stolen and part of my system that I was putting together to protect the American People was stolen but the DOJ did absolutely nothing to protect us or stopping this from happening.

Our two attorneys that were illegally involved and his Secretary were never arrested for making a False Police Report. Attorney Victor Carl Krumm was banned from ever practicing law in the entire United States of America and he fled to Costa Rica where he still resides there today. The Other Attorney Ben Kay was also banned from ever practicing law in the entire United States and he resides in Florida.

The Hartford Insurance Company sued Victor Carl Krumm for filing an Insurance Fraud claiming that I, Anthony Martini stole his computer. Victor Carl Krumm' Computer was still at his Law Office when he filed an Insurance Fraud.

The Hartford Insurance Company cancelled all of Victor Carl Krumm' Insurance Policies and banned him from all Insurance Companies.

On January 23, 2003 I, Anthony Martini and I, Annette Martini drove from Sarasota, Florida to Miami, Florida to meet with the INS. The Emergency Meeting was arranged by THE WHITE HOUSE. We were told that the INS would financially assist us but that did not happen at all because we were not CUBANS so the INS refused to assist us, so we drove back to Sarasota, Florida where we lived in our car from 2002 to October 2006.

In July 2003, I, Annette Martini got pregnant. I, Annette Martini had severe cramps and the Sarasota Memorial Hospital, in Sarasota, Florida refused for me to be admitted into the Hospital. I ended up having a miscarriage in the streets of Sarasota, Florida and holding the remains of our unborn child in my hands.

We both lived in our Car waiting and waiting for the United States Federal Government to allow us to legally work in the United States and we suffered for being honest and for coming into the United States the Right Way, Legal Way, the Diplomatic Way and with Permission.

In March 2004, THE WHITE HOUSE ordered the Social Security Office to issue myself, Anthony Martini and myself, Annette Martini, a SOCIAL SECURITY NUMBER. However, the Social Security number was not active until late 2006.

At the same time THE WHITE HOUSE made sure that the U.S. Homeland Security issued myself, Anthony Martini and myself, Annette Martini an E.A.D. Card (Employment Authorization Card).

In 2004, I, Anthony Martini and I, Annette Martini received DEATH THREATS from an African American by the name of EDWARD HARRIS from DHS – U.S. Department of Homeland Security who said as follows:

“I WILL PLAY WITH YOUR FILES AND YOUR WIFE’S FILES AND I WILL USE MY BOYS TO KICK YOU OUT OF THE U.S. AND I WILL USE YOU AND YOUR WIFE AS MY NEW SEXUAL PLAYTHING.”

We received thousands of threats and death threats from Edward Harris who is employed by U.S. Homeland Security from 2004 – 2012. Even the day before we were kidnapped. The White House had copies of those Death Threats and so did the

U.S. Department of Justice and nothing was ever done. Even the FBI was notified numerous times but the FBI were so useless when it came to death threats against us from another State and from a United States Government Employee.

In late October 2006, I, Anthony Martini rented a van and we both moved to the State of California.

As soon as we got our first apartment in Costa Mesa California, we immediately contacted the U.S. Homeland Security and supplied them our mailing address in Newport Beach, nearby. We were given permission to use a UPS Mailing address because of the severe Death Threats that we were both receiving from Edward Harris from U.S. Department of Homeland Security.

As soon as we got our first apartment in the United States I, Anthony Martini had our mail forwarded to California.

A Few weeks later we received our mail from Florida and from the U.S. Homeland Security that gave us a NOTICE TO VOLUNTARILY LEAVE THE UNITED STATES OF AMERICA because the United States Government claimed that they did NOT know what P.O.E. – Port of Entry that we entered. This was all done by EDWARD HARRIS who used his co-workers as he promised he would.

We both had a letter from the United States Department of Justice – DOJ that said, “YOU MAY REMAIN IN THE UNITED STATES.”

I, Anthony Martini and I, Annette Martini had our case transferred from Orlando Immigration Courts to the Los Angeles Immigration Courts and the False Charges against us both kept on changing. The False Charges against us are below:

“POE UNKNOWN” that False Charge against us was illegally changed to”

“YOU ENTERED THE UNITED STATES THROUGH THE POE OF MIAMI, FLORIDA AS STOWAWAYS.” that False Charge against us was illegally changed to”

“YOU ENTERED THE UNITED STATES ON A B1 or B2 VISA” that False Charge against us was illegally changed to”

“YOU ENTERED THE UNITED STATES THROUGH THE P.O.E. OF PLATTSBURGH. NEW YORK ON JULY 24, 2002. HOW DO YOU PLEAD GUILTY OR NON- GUILTY?” This was only a statement.

We could NOT afford an Attorney and since I, Anthony Martini studied law and passed my Bar Exam in Canada, I knew that I could handle our Immigration Case.

Our case illegally lasted from January 2007 to the day we were kidnapped on October 24, 2012 and lasted into 2013.

We went to the Corrupt B.I.A. – U.S. Board of Immigration Appeals 4 times.
We both went to the Ninth Circuit Court of Appeals in San Francisco about 3 Times.

We both went to the United States Supreme Court about 3 Times. We paid for all filing and again Justice was denied because of massive corruption at the U.S. Homeland Security and the U.S. Department of Justice.

We continued going to the United States Immigration Court in Los Angeles, California and continued being before Corrupt Government Judges and Corrupt United States Attorneys, that we sued twice.

We both wrote to every United State Attorney General to stop the Gross Human Rights Abuse and to conduct a Criminal Investigation and to STOP our FALSE REMOVAL PROCEEDINGS and each letter that we sent to the DOJ we received more persecution.

We even demanded that Former President Barack Obama stops the FALSE REMOVAL PROCEEDINGS and conduct Criminal Investigations and arrest all involved. That never happened and then the persecution got out of hand.

In 2012, I wrote on my Personal Website “DO NOT RE-ELECT PRESIDENT OBAMA.” My website received over 4 Billion Visits worldwide and we received more traffic than all the U.S. Media Combined.

Former President Barrack Obama decided to violate FREEDOM OF SPEECH and he personally ordered the United States Military mainly the U.S. ARMY to hunt us down, who are civilians and Political Refugees on American Soil.

Former President Barrack Obama even authorized a Private Company to hunt us down and that Private Company was paid \$10 Million Dollars tax money, according to the United States Government Employees at ICE – Immigration Customs and Enforcements.

We tried to leave the United States of America to go to FRANCE or ITALY and both Countries violated International Laws. We even went to the FRANCE CONSULATE in Los Angeles, California and to the ITALIAN CONSULATE in Los Angeles, California and declared Emergency Protection and Emergency Sanctuary and Emergency Refuge but both Consulates violated International Laws. We could not leave the United States without a Passport and neither myself, Anthony Martini or myself, Annette Martini had any passports or any citizenship from any Country.

We continued receiving more and more death threats from EDWARD HARRIS from U.S. Homeland Security and his friends on a weekly basis.

We were both still attending every Court Appearance at the United States Immigration Court and we both never ever broke any American Laws or United States Immigration Laws.

On Wednesday, October 24, 2012 the cockroach motel where I, Anthony Martini and I, Annette Martini were living at for over one and half years, was surrounded by U.S. Military Helicopters and Snipers.

I, Anthony Martini was kidnapped and taken to 300 north Los Angeles Street, in Los Angeles, California, where I was tortured for about 13 hours which was the U.S. Homeland Security Detention Facility, by putting me in the freezer. I was denied food and heart medications of which I suffered severe chest pains because of the torture. I was also denied my legal rights to contact an Attorney or the FBI to report a kidnapping.

I, Annette Martini was also kidnapped and taken to 300 north Los Angeles Street, in Los Angeles, California and I was denied my legal rights to contact an Attorney or contact anyone to assist us and stop the kidnapping.

I, Anthony Martini was illegally taken from Costa Mesa, California to the HIGH DESERT in California about 4 hours away to a Private Detention Facility run by THE GEO GROUP. The Detention Facility is called The Adelanto Detention

Facility also known as “THE ADELANTO CONCENTRATION CAMP where they physically torture detainees in ICE custody and where I was physically tortured.

I, Annette Martini was taken to the CITY OF SANTA ANA JAIL and illegally held in ICE CUSTODY with no access to courts.

I, Anthony Martini was physically assaulted as soon as I arrived by an African American Guard and by ICE and I was knocked out cold and kicked in my head and in my back numerous times. My left side of my face was all black and blue. I have no idea how many days I remained unconscious in Solitary.

ICE and GEO refused to tell me where I was taken to except to say it was a SECURE AND ISOLATED LOCATION.

I was physically tortured on a daily basis, and heavily and viciously interrogated on where I put my FOUR BILLION DOLLARS. I NEVER HAD FOUR BILLION DOLLARS OR EVEN ONE BILLION DOLLARS OR EVEN A MILLION DOLLARS.

ICE and DHS presumed that since I received over four billion visits on my personal website that told the entire world what Canada did to us and how the United States left us Stateless, then all visitors donated on my website and therefore I have four Billion Dollars.

Actually, we only received about \$200.00 in donations from 2004 – 2012. All visitors assumed that the next person would help and that never happened.

Every day, I was threatened to sign papers to leave the United States of America even though we were still before the BIA – U.S. Board of Immigration Appeals. Every day, I was threatened that they (ICE) would rape my wife and kill my wife, if I did not sign.

I, Anthony Martini was told by ICE many times that my wife, Annette Martini, filed for a divorce and that she signed the papers and left for Canada, which was a lie.

I, Anthony Martini was threatened by ICE that they would kill our children if I did not sign to leave the United States.

I, Anthony Martini was threatened by ICE (JOSE G. BARR) number 2 Ice at Adelanto Detention Facility that he would cut me to pieces and send me to Canada.

I, Anthony Martini was placed in Solitary and tortured for 5 full days, 24 hours a day and I was also tortured by sleep deprivation which is against the GENEVA CONVENTION against TORTURE. I was placed in a freezer for 5 full days with no blankets or pillow and no heart pills and I could see my breath.

I, Anthony Martini caught pneumonia 6 times in 11 months and the nurses were denying me antibiotics and heart pills on orders of ICE and mainly Wesley LEE number 1 ICE and Jose G. Barr number 2 at ICE at the Adelanto Detention Facility. However, the doctors gave me extra heart pills and extra antibiotics and told me to hide them from GEO Guards and from ICE. The doctors knew that ICE were trying to murder me and they wanted no part in the illegal activities and murder. Those two good doctors were fired for not taking orders from ICE to commit murder.

On February 28, 2013, I was assaulted by an African American that was ICE employee. That assault caused severe right leg injury, severe left shoulder injury and caused my 5th heart attack.

In August 18, 2013, ICE placed poison in our foods and live worms and bugs trying to kill myself, Anthony Martini and others in the dorm.

In August 2013, I was taken from Adelanto Detention Facility, in Adelanto California, back to 300 North Los Angeles Street where I was threatened by 5 ICE – Immigration Customs and Enforcements Employees. I was threatened with violence if I did not sign the papers to leave the United States to go to Canada. ICE kept on reminding me that they had my wife, Annette Martini in custody which was a threat.

I was again placed in the FREEZER for about 9-10 hours and again heart pills were denied.

In August 2013, ICE ordered THE GEO GROUP at the Adelanto Detention Facility to install GAS CANISTERS in all Dorms. One Gas Canister was to put all detainees to sleep and the other Gas Canister was to kill all detainees.

In August 2013, around 4:00 PM, ICE placed a blanket under the door and the guard walked out of the dorm and ICE used the Gas Canister on all detainees. We were all

knocked out cold from 4:00 PM to midnight. Everyone had nose bleeds. My nose bleed lasted until late 2015.

In August 2013, ICE left me outside in the desert heat for about 5 hours and refused for me to go back inside which resulted in **THIRD DEGREE BURNS** to the top of my head, which still bothers me to this day, because I cannot go out in the sunshine of warm weather because the top layer of my head is severely burnt.

In August 2013, I WAS THREATENED by ICE Wesley Lee, Joe Barr, RICCARDO RICHIE that ICE has a letter from Washington, D.C. giving them permission to tie up my wife, Annette Martini, to Taser my wife, to drag my wife by her hair, to use full lethal force too and to kill my wife and put her on the plane, back to Canada. I did see that letter on a Government Letter Head, which I believe was U.S. Homeland Security Letter Head.

I was forced by gun point to sign the papers to save my wife, Annette Martini. We already signed the Travel Documents to be deported to FRANCE or ITALY and ICE Government Employees refused to talk to either Country or give them the Travel Documents. ICE even said that both countries refused you both but ICE refused to show the refusal letters that never existed.

ICE took my hand by force and took my fingerprints to give to Canada. The only place that had my fingerprints in Canada was when I, Anthony Martini was in the Canadian Military.

I, Anthony Martini told ICE that I would go to CHINA, or RUSSIA, or any Country in Europe except Canada and I even explained to ICE over and over again that I ANTHONY MARTINI am NOT a Canadian and nor is my wife, Annette Martini, but ICE and DHS Employees wanted me dead at all cost and told me that the only place that they would send myself and my wife was to Canada so Canada would finish us both off and murder us.

All my life, I, Anthony Martini always said that I was born in Italy and that is where I was born. Annette Martini, my wife, always said that she was born in Quebec, Canada and that is where she was born. ICE refused to deport us to ITALY or FRANCE saying that we would be happy there and they only wanted to send us to CANADA so CANADA will finish us off and murder us.

ICE already illegally tried to deport my wife, Annette Martini to Vancouver, Canada But Annette never lived in Vancouver, Canada and nor was she born in Vancouver, Canada BUT ICE had a Canadian Travel Document stating that Annette Martini my wife was born in Vancouver, Canada.

ICE told me that my wife, Annette Martini, was deported to CANADA and that she was killed in Canada by the Canadian Government. THIS IS TORTURE, which is against United Nations Laws.

I even contacted the Canadian Consulate in Los Angeles, California, that ships massive street drugs into the western United States and I was told that my wife, Annette Martini, was placed on a plane back to Canada. Even the Canadian Embassy in Washington, DC lied to me and said that my wife was on a plane to Canada and they would not tell me where she was deported.

I, Anthony Martini sent a letter to my wife, Annette Martini at the Santa Ana City Jail, hoping that this was not true and that ICE were continuing with their LIES.

I, Anthony Martini had to wait for days before I received a letter from my wife telling me that ICE illegally tried to put her on the Plane to Canada and she refused and that she was extremely scared for the first time.

I, Anthony Martini was forced to meet with WESLEY LEE, JOSE BARR and RICCARDO RICHIE to stop the illegal deportation of my wife that never broke any laws in the United States of America. I, Anthony Martini made a deal that my wife and I get deported together on the same bus, and the same plane and these criminals and kidnappers WESLEY LEE, JOSE BARR and RICCARDO RICHIE agreed to my terms as long as I sign papers, by force, to leave the United States of America to go only to Canada.

I, Anthony Martini again wrote to my wife, Annette Martini and explained to her that I made a deal with my enemies and my kidnappers for both of us to leave together back to Canada that persecuted us for many years.

ICE took myself, Anthony Martini, around September 3, 2013 after 11 months being illegally detained at the Adelanto Detention Facility in Adelanto, California and where I was physically tortured every day and ICE took me back to 300 North Los Angeles Street, Los Angeles, California (ICE DETENTION FACILITY) where I was supposed to meet my wife, Annette Martini.

This was the first time I saw my wife, Annette Martini, since we were kidnapped. I was totally shocked and devastated. Annette Martini, my wife, looked like someone that just came from a Concentration Camp. She weighed about 70 lbs. Her face all dropped and sagged. I could see her bones and her pants was 5 times bigger than her and she had to tie her pants and hold it up from falling. ICE Smiled and said "DOES YOUR WIFE LOOK GREAT." GOD had to give myself so much strength that day to hold back not to hit my kidnappers.

My wife looked at me and now I have 3 lost teeth because of the abuse and torture.

We were both again forced to sign illegal papers indicating that we are banned from the United States for 10 years of which we know it is an illegal life time ban.

My wife and I were placed on a BUS but no one would tell us where we were going indicating that it was classified. We were taken to San Diego, California and illegally placed on a CON AIR FLIGHT in handcuffs and shackles.

We were flown from San Diego, California to TEXAS. Then we were forced on another plane from TEXAS to ARIZONA. Then from ARIZONA we were put on another CON AIR to Louisiana where we both were taken to another GEO Facility.

We both stayed in LOUISIANA for about 5 days, then we were both taken by CON AIR to Pennsylvania, where we were both forced to have finger prints and eye scans. We stayed at the Jail in Pennsylvania for a night and then we were taken by Van to Buffalo, New York and again being finger printed and had eye scans. Annette Martini, my wife, was illegally placed in a City Jail in Buffalo, New York.

At the Buffalo Federal Detention Facility I, Anthony Martini was told by ICE employees that President OBAMA ordered our kidnapping and that ICE AGENT JOSE BARR made arrangements with the RCMP to have us both executed at the border in Canada.

I, Anthony Martini was assaulted by the Canadian Border Agent that severely damaged my damaged shoulder that was damaged by ICE employees.

The America ICE AGENTS that participated in International Kidnapping waited for a REWARD to hand us over to the Canadian Government. They looked like a couple of pan handlers with tin cans waiting for their money, for kidnapping us.

I, Anthony Martini and I, Annette Martini were forced back to Canada with only the clothes on our backs and with no identifications.

The Corrupt American Government Employees from ICE stole, all of our expired identifications.

U.S. Homeland Security refused to renew our E.A.D. – Employment Authorization Card in August 2010, which forced CALIFORNIA DMV to refuse to reissue us both our Driver's License.

Corrupt Government Employees from U.S. Homeland Security contacted our Banks where we had Business and Personal Bank Accounts and Illegally forced our Banks to immediately close our Bank Accounts both Business and Personals. They even contacted the place where we rented our apartment for 4 years and threatened them to cancel our lease and they did.

These Corrupt United States Government Employees should be charged, for all of their crimes, torture, human rights abuse and kidnapping against us.

About a month after we were both forced back to Canada, I noticed that the Canadian Travel Document was FORGED.

The Travel Document that ICE was not supposed to give us for my name ANTHONY MARTINI said “ I WAS BORN IN CANADA IN AN UNKNOWN CITY.”

Any Canadian or any Government employee from the Canadian Embassy or Canadian Consulate would never put “UNKNOWN CITY.”

For the Travel Document for myself, Annette Martini, for place of birth it said “I WAS BORN IN VANCOUVER, BC.” THIS IS ANOTHER LIE and this Travel Document was FORGED.

I, Anthony Martini, did conduct a full investigation against the Canadian Consulates in the United States and at the Canadian Embassy in Washington, DC and concluded that NO Canadian Consulates or Canadian Embassy in the United States ever issued the American Government or ICE any travel documents.
