### **LEGAL NOTICE**

Attention: Hon. Rhéal Éloi Fortin (Interim Leader of Bloc Québécois),

This is a Legal Notice that the Plaintiffs Anthony Martini and Annette Martini will be filing a Lawsuit against the **Bloc Québécois** and previous Bloc Québécois Politicians.

Bloc Québécois and its previous Members of Parliament are **NOT Immune** from this Lawsuit under International Laws, United Nations Laws and the International Community.

Hon. Rhéal Éloi Fortin, it is your Legal Duty and your Legal Obligation to make sure that all Provincial Politicians of the Province of Quebec and all previous members of the Bloc Québécois Party and all Bloc Québécois current members receives a copy of this attached Legal Notice that was served upon Prime Minister of Canada Justin Trudeau.

The Bloc Québécois Party and the Province of Quebec are being sued by the Plaintiffs Anthony Martini and Annette Martini for GROSS HUMAN RIGHTS ABUSE, and Human Rights Violations.

The Plaintiff Anthony Martini is suing the Province of Quebec for concealing the whereabouts of his 2 kidnapped daughters.

The Plaintiff second daughter was kidnapped in 1997.

The Province of Quebec and the Bloc Québécois Party are also being sued for telling the Plaintiff that his kidnapped daughter was murdered at 17 months old by the kidnapper.
